### Note:

1. After receipt of Renunciation Certificate, the original NICOP/CNIC may be forwarded to Director (IOD), NADRA, Headquarters, G-5/2, Islamabad along with copy of renunciation certificate, under intimation to this Directorate General.
2. The Renunciation Certificate would be issued as per Form "X". Therefore name spellings on form "X", NICOP, Pakistan Passport, Assurance letter/foreign Passport should be the same. In case of any variation/name change, an application with supporting document may be attached with the application.
